Several members of the public spoke against the planning application at Land to the West of Shrewsbury Road, Cockshutt. The main concerns were the proposed access to the site through Kenwick Close and also access from Kenwick Close onto Shrewsbury Road. There were concerns that plans were not accurate regarding trees.

Concerns were also raised by a representative of the Millennium Hall Management Committee who confirmed a formal objection had already been submitted to Shropshire Council.
