96/15 Parish Matters:

a. Surface of footpath through Cockshutt Church

The Chair reported that sufficient stone to cover the small areas had been donated and it was suggested that members of the Church could provide the labour.

b. Rights of Way in Parish

It was noted that some residents have mistaken Stewardship Margins for footpaths. It was agreed that an article in the newsletter would help to inform/educate residents. Farmers would also be encouraged to clear footpaths through crops.

97/15 Highways:

a. Sites of Community Concern Submissions - Shropshire Council Road Safety Policy

It was resolved to submit the following concerns:

- 1. The excessive traffic speed through Cockshutt, specifically, approaching from the Shrewsbury end of the village.**
- 2. The concern for children's safety in the immediate vicinity of Cockshutt Primary School, here the PC is requesting a 20mph Zone.**
- 3. The inadequacy of the Roundabout at the junction of the Meadows development, and the Village Hall. Rights of Way rules are rarely observed, and overtaking on the roundabout has been observed on several occasions.**
