Cllr. J Cooling reported that the Village Hall Committee consider they need to identify sources of income whether by fundraising events or otherwise.

WMAS "Saving time, Saving Lives"

Cllr Morris has investigated the possibility of grid reference cards and spoke with WMAS. Even though it was a good idea the conclusion was that in such a rural location it was less likely to work and would be expensive to produce the cards. SALC had circulated an e-mail with an invitation to visit WMAS operations centre at either Brierley Hill or Stafford.

The Chair had received a communication from the Post Office informing of its likely closure due to the retirement of the current incumbent. The Parish Plan Steering Group identified the issue and attempted to initiate group to take on the Post Office & Shop as an ACV; the Chair has received an enquiry offering help. The issue is ongoing running of it as it is unlikely to be a commercial venture with an adequate return to employ someone; it would need volunteer help.

Cllr. Lewis reported that the Community Speed Watch is up and running from today.
