159/21 Financial Matters:

- a. Balances for information circulated to members were noted and accepted
- b. Other than the standing orders/direct debits for this period, there were no other payments for approval
- c. Budget Discussions.
No further amendments from November meeting. Clerk reported that the SALC affiliation fees will be increased 3.5p per elector which represents circa £35.00 per annum. The tax base figures are expected from Shropshire Council around 15th December.

- d. Purchase of Youth Shelter for the Sports Field
Members having discussed the installation of a youth shelter proposed and seconded, all agreed the smoking shelter type from Ace Shelters modified as a youth shelter; cost £4,195 plus VAT. Currently awaiting quotes for the base.
RESOLVED: The costs for purchase and installation of the ACE Shelter is approved
- e. Purchase of Dog Bin
As reported at the November meeting, the Clerk has instructed Shropshire Council to install the new dog bin in the preferred location. Not yet installed.
- f. Purchase of Bench for Church Green
Members agreed responses to Connexus requirements for installation of the bench. Members to survey the site in January and agree the position of the bench & provide a plan as requested. Monitor the litter situation after the bench is installed.

160/21 Application for funding to repair the fabric of the building – PCC, St Simon & St Jude

Members acknowledged the receipt of the request from the Church; unfortunately, due to legal restrictions, the Parish Council is not permitted to use funds to support the church for this purpose.

161/21 Upgrade to Children’s Play Area, Millennium Hall

The Hall Committee are considering quotes received from Ray Parry and Playdale with a view to submitting an application for funding to the Parish Council.

163/21 Jubilee Field

The Parish Council are still awaiting a decision on the application for hedging plants from the unitary authority tree scheme.

The Clerk reported on the Queens Green Canopy scheme, details circulated 2.12.21 - To support Parish Councils who have yet to get involved, a free standard or ‘feathered’ tree (1 to 2m high) plus a commemorative plaque to mark the planting is available. Trees can be mapped on the website.
