# 147/23 Apologies for Absence

None

# 148/23 Public Participation

a. A resident commented on the application for 6 dwellings at the Parklands that the development is outside development area for the village. The land contains springs and flooding has always been an issue therefore it is the wrong place to develop. Soakaways and storm drains are not adequate. It is the wrong type of property for village needs. Also, the additional vehicle movements which would be required exacerbate to the problem of poor visibility at the junction with the main road, inadequate footpaths from Parklands down to the main road and lack of infrastructure and public transport to support new properties. The development would have an adverse impact on protected wildlife which has migrated to the site.

The Chairman explained that in the past the Parish Council has pursued the issue of flooding at the Parklands, blockages had been cleared but as soon as heavy rains come the problem reappears & the drainage outlets are not adequate.

Cllr. Williams acknowledged the concerns and also explained that any road issues would be at the developers' cost.

b. Residents from Crosemere Crescent raised a concern with the drainage infrastructure in Cockshutt questioning whether it was fit for purpose in 2023 and beyond. The drains take both surface and foul water to Cockshutt Sewerage Pumping Station and it appears that during periods of heavy rain the station is not able to cope with the flow of surface and foul water as it frequently overtops the storage chamber resulting in flooding around the station onto the highway & in the adjacent field. This seems to be exacerbated by the additional development which has taken place in recent years. Residents in Crosemere Crescent suffer frequent blockages with toilets and manholes backing up and foul water overflowing onto their gardens & drives. Residents have reported issues on more than 20 occasions to Severn Trent however the issue is not resolved and is getting worse. Residents requested that the Parish Council support them in their effort to get a resolution to this issue.

- evidence from the residents support the objection that this is not a suitable site as the drainage issues are unresolved. It is noted that work has already been done by filling in of the pond & as such there is nowhere for the water to go; the only way of draining the land is to the highway drains which are inadequate
