# 16/24 Public Participation

A Petton resident expressed appreciation as the potholes on Petton Lane have now been filled.

Petton residents would like, if possible, something in the Parish Matters regarding Freedom Fibre Project Gigabit & encouraging residents to express their interest in broadband upgrades.

ITV interviewed some parish residents for an ITV Tonight piece on planned replacement of copper wire connections in rural areas.

Rev. Gareth Ingram made a request for financial assistance with the sound system for church. There has been a long term problem with the loop system in church. The Church currently has WiFi & camera is installed. The church would like to get a full system for live streaming events in the Church. The cost of the system is £7,100, the church already had a grant of £3,200. Cllr. Williams recommended Shropshire Historic Churches Trust for grants.

A resident requested an update regarding internet and mobile connections following the proposal by Clarke Telecommunications to install a mast in this area and requested the Parish Council pursue this.
