29/24 Apologies for Absence

30/24 Public Participation

A local resident and gardener attended the meeting and offered advice regarding management of the wildflower meadow. He gave a short history of wildflower meadows. Members would like to meet with him to benefit from this advice.

In respect of the Parklands development and the recent planning application, residents from Parklands added two points; firstly, the development land has flooded onto the road in 4 instances when it has been up 1-2 ft deep outside the houses opposite, and secondly, the pumping station has been overwhelmed at least twice this year.

A governor of Cockshutt Primary School attended and updated the Parish Council that the schools are to change to academy status following consultation with the parents. They are applying to join Marches Academy Trust schools. The considerations which led to this decision, that Shropshire Council no longer has the resources now to support the schools as they would like & Marches has access to staffing and funding; the schools remain independent and have a strong community focus. Hopefully the process will be complete by 1st August in time for September intake. The Parish Council may well be consulted on the proposals later in the year.

Members agreed to object on similar grounds to the previously withdrawn

application.

With regard to streetlights, in general, the casing lasts about 10 years and the lamp itself about 3 years. The contractors keep a record of which streetlights we own but don't record when lamps are replaced.

Lights which are too bright at night, the Parish Council could adopt part night lighting, which means switching lights off generally between midnight and 5:30 am. Shropshire Council has developed guidelines for streetlights which would be the exception and remain on all night. Clerk and Cllr. Harrison meet with Highline in respect of street lighting issues.
