123/23 Airband Wayleave Agreement

Members received feedback from the Village Hall Committee that the telecoms pole should not be sited at the entrance to the Village Hall as it is unsightly. The Chairman recommended that the PC invite suggested alternative locations from the Village Hall Committee with a view to meeting with Alrband to discuss the matter.

It was more of an introductory meeting with it being the first one. Cllr. Lewis reported damage caused to the fence around the play area. SNT reported they patrol the village as much as they can – and the Millennium Hall in particular – but there is currently a shortage of vehicles which makes it difficult.
