## 92/25 Environmental Maintenance:

The Parish Council noted a report that the graveyard grass has not been cut. The grass cutting in the graveyard is not within the Parish Council's (PC) remit although the PC does contribute to grounds maintenance by way of grant. Members to make enquiries of church wardens.

## 93/25 Jubilee Field

a. Drainage

No quotes received to date. Drainage contractors have suggested a perforated drain to accommodate the car park area and alleviate the ponding problem on the field. Cllrs. Griffiths and Webb have investigated the flow of water through the existing drain from Jubilee Field to the road drain, it appears to be flowing effectively.
